November 14th, 2018 - Dental facilities that do not discharge their amalgam process wastewater into a POTW are also not subject to any of the rule's requirements including submission of a one time compliance report to their Control

November 5th, 2018 - When cleaning dental unit water lines chair side traps and vacuum lines that discharge amalgam process wastewater do not use oxidizing or acidic cleaners including but not limited to bleach chlorine iodine and peroxide that have a pH lower than 6 or greater than 8

November 10th, 2018 - At large dental facilities such as those serving the armed services advanced treatment systems for amalgam capture are required by the local wastewater treatment facility This seems very appropriate since the amount of amalgam discharged to the sewer from such facilities is very high compared to most municipalities

November 12th, 2018 - The pretreatment program regulates industrial facilities discharging wastewater to publicly owned treatment works POTWs These facilities known as industrial users discharge process wastewater often contaminated by a variety of toxic or otherwise harmful substances
